I hereby acknowledge and agree to the terms and conditions set forth in this non-liability waiver as a visitor at Verneukpan Rest Camp.

I understand and accept that my visit to the Camp site involves inherent risks and potential hazards, and by participating in any land and water activities on the Campsite premises, I voluntarily assume all risks associated with my visit.

I acknowledge that this Agreement releases Verneukpan Rest Camp and its owners, employees, and staff from any and all liabilities for personal injury, property damage, or wrongful death that may arise from my presence or activities at the Campsite.

1. Under the Influence or Reckless behaviour:

I Understand and agree that if I am under the influence of alcohol, or any other substances impairing my judgment or physical abilities, Verneukpan Rest Camp will not be responsible for any accidents, injuries, or damages that may occur as a result of my impaired state.

2. Wild Animals:

While Verneukpan Rest Camp has never experienced any attacks by wild animals on humans, I acknowledge that there is potential wildlife in the vicinity of the Campsite. I acknowledge and accept that Verneukpan Rest Camp is not liable for any harm, injury, or damage caused by these wild animals to me or my property during my visit.

3. Visitor's Experience and Knowledge:

I hereby affirm that I am an experienced camper and possess the necessary knowledge, skills, and abilities required to navigate and survive in outdoor environments. I understand that Verneukpan Rest Camp assumes visitors have a basic understanding of camping practices and will act responsibly during their stay.

Verneukpan Rest Camp will in no way be held liable for any reckless driving, dicing of vehicles, high speed driving or any other accident/incident happening while driving vehicles in and around our campsite. This includes motorcycles, quadbikes, scooters etc.

4. Adverse Weather:

I understand and acknowledge that weather conditions at Verneukpan Rest Camp can change rapidly. I agree that it is my responsibility to exercise good judgment and take necessary precautions, including seeking shelter or leaving the campsite if adverse weather conditions arise. Verneukpan Rest Camp shall not be held responsible for any incidents, injuries, or damages resulting from adverse weather conditions.

5. Falling Trees, Branches, and Vegetation:

I acknowledge that the campsite is surrounded by vegetation. I understand and accept that Verneukpan Rest Camp shall not be held liable for any injuries or damages caused by falling trees, tree branches, or vegetation during my visit to the campsite. 8. Vehicles and Parking:

I understand and agree that Verneukpan Rest Camp is not responsible for any damage, theft, or loss involving vehicles parked or driven on the property.
